Dear Friends,

As we reflect on 2012, we are mindful of our indebtedness to you as we move forward with our medical mission work. Without your partnership we would be unable to continue to serve in this important capacity. Little by Little remains a growing non-profit organization. We maintain our core values of partnership, reciprocity, sustainability, transparency and universal care.

At Little by Little we understand there is no "one-size fits all" model to development and we take pride in our unique approach. We operate both as a development organization and as a foundation. We receive gifts and donations that we use to facilitate our cornerstone activity- medical mission trips to Mountain Top Ministry's (MTM's) health clinic in Gramothe, Haiti. In 2012 four teams of volunteers traveled to Haiti to give care and comfort to many. Portions of Little by Little's funds combined with our volunteer's expertise in many medical specialties are also utilized to build capacity with other organizations who are working on the ground in Haiti. Such partnerships allow Little by Little creating broad service opportunities that are complimentary and important to our mission of partnering to improve health and well-being for all.

In partnership with MTM, in 2012 we refined a computer-generated inventory system as a model for the medical clinic pharmacy. This inventory system allows each visiting medical team to accurately know all medications available along with quantities and expiration dates. Purchasing and ordering medication is becoming more precise and efficient which will eliminate waste of both medications and funds. This new system will benefit all.

This year Little by Little has also partnered with Global Health Action (GHA) to assist them in a needs assessment for the district

of Petit Goave, an area which was ravaged by the 2010 earthquake. GHA services this area through a community clinic and by training and supporting traditional birth attendants and community health workers. Nutritional support and vaccine programs are a priority. Capacity building through these various partnerships allows Little by Little to fulfill our mission to faithfully partner with those in need.

Solidifying our core value of reciprocity in 2012, many volunteers gave much of themselves through their time and talents yet have expressed that they received much more than they shared. Four teams equates into over 100 volunteers providing medical care. In addition many church groups, schools and community groups collected and packed up needed supplies. Through reciprocity we recognize that in reality two communities are served by the work we do, both in Haiti and in our own communities. The reward is great for each who serves with us and for those whom we serve.

We would like to express heartfelt appreciation for the generous support Little by Little has received this year. Thank you for sharing your blessings with us so that we can continue to share your blessings with those we serve in Haiti.
